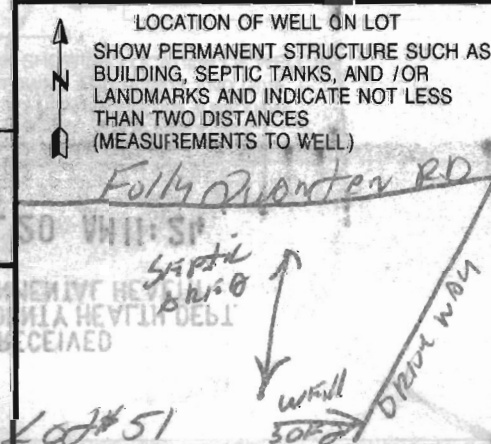

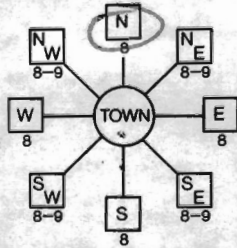

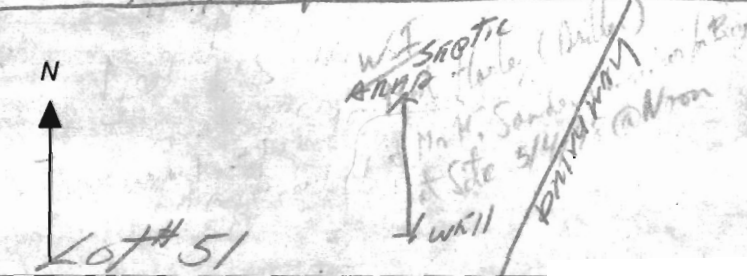

WELL EASEMENT AGREEMENT

THIS WELL EASEMENT AGREEMENT, (this "Agreement") is made and entered into this 26th day of May, 2010, by and between HONG-TAO MA and XIAO-HONG LI, parties of the first part and MAISEL PROPERTY HOMEOWNERS' ASSOCIATION, INC., a Maryland Corporation, party of the second part.

WITNESSETH:

WHEREAS, the parties of the first part are the owners of an improved lot or parcel of ground known as Lot No. 51, as shown on a Plat entitled, "Buckskin Woods, Lots 50-54 (A Resubdivision of Lot 26, Buckskin Woods and Lot 9 Buckskin Farms), Sheet 2 of 2", which plat is recorded among the Land Records of Howard County, Maryland in Plat Book M.D.R. No. 11117 (hereinafter referred to as "Lot 51"); and

WHEREAS, the party of the second part is the owner of Open Space Lot No. 6, situate, lying and being in the Fifth Election District of Howard County, Maryland as shown on the Final Record Plat entitled, "Maisel Property, Lots 1 thru 6 and Preservation Parcels A & B" and recorded among the Plat Book Records of Howard County, Maryland as Plat Nos. 14524 thru 14527 (hereinafter referred to as "Lot 6"); and

WHEREAS, the Owners of Lot 51 purchased the lot with the use of an existing well having Howard County Tag #94-1546, believing that that well which served the improvements on Lot 51 was on Lot 51; and

WHEREAS, it has been recently discovered that the existing well #94-1546 serving Lot 51 is actually located on Lot 6; and

WHEREAS, the Owners of Lot 51 have requested from the Owner of Lot 6 a permanent easement to maintain and said improvements; and

WHEREAS, the Owner of Lot 6 has agreed to grant such an easement, subject to the conditions more fully set forth herein.

NOW, THEREFORE, WITNESSETH; that in consideration of the mutual promises and covenants of the parties hereto and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The party of the second part, for itself, its successors and/or assigns, hereby grants and conveys to the parties of the first part, their heirs, personal representatives and assigns, an exclusive twenty foot wide (20') by sixteen and thirty-six one-hundredths foot (16.36') long perpetual easement across Lot 6 for ingress and egress to the existing well as more particularly shown on Exhibit "A" (the "Well Easement Area") attached hereto and made a part hereof;

2. The parties of the first part shall be responsible for maintaining the Well Easement Area at their sole cost and expense and shall indemnify and hold harmless the party of the second part from any liability, cost or expense incurred in maintaining the Well Easement Area;

3. The party of the second part agrees not to erect or permit anything to be erected within the Well Easement Area or to fill or excavate within the Well Easement Area without the express consent of the parties of the first part;


4. The parties of the first part shall have the right of ingress and egress over, under and across the Well Easement Area for the purpose of inspecting, maintaining and replacing the well and laying and maintaining and replacing any supply pipes servicing the well;

5. This easement shall run with the land and be binding upon all parties having or acquiring any right, title and interest in the above described properties and shall inure to the benefit of the owners and their respective personal representatives, successors and assigns.



This is to advise you that the septic system installation and water well construction for the above referenced property have been inspected and approved. Final approval of the septic system was granted on **12/5/2011**. Final approval of the well line connection to the dwelling was granted on **10/26/2012**. The well construction was completed on **6/9/1998**. Water samples were collected on **6/26/2013**.


The water sample results indicate that the water samples submitted for testing were free of coliform and fecal coliform bacteria at the time of sampling and are bacteriologically safe for drinking. This certifies that the initial sampling requirements of COMAR 26.04.04 "Well Regulations" have been met for the water supply system installed under well permit HO-94-1546. Although the submitted sample results are in compliance with COMAR standards, the Health Department does not guarantee water supplies.

This Interim Certificate of Potability will expire **six months** from the date of issuance. Submission of a second bacteriological test indicating the water is free of coliform and fecal coliform bacteria is required prior to the expiration date, after which time a Final Certificate of Potability will be issued. **Failure to submit an additional sample and obtain a Final Certificate of Potability will result in a Notice of Violation and is punishable as a misdemeanor under the Annotated Code of Maryland, Environment Article, 9-1311, subject to a fine of up to \$500 or imprisonment not to exceed three months.**
